Lawrence County Board of Health August 18th, 2021, Minutes

Roll Call: The meeting was called to order at 4:51 PM. Present were Lois Herrell, Brenda Shipley. Also present was Georgia Dillon, Health Commissioner; Angela Bostick-Doyle, Director of Nursing; and Zach Schweinsberg, Fiscal Officer. Randall Lambert, President of the Board, arrived at 4:59 PM.

Approval of expenditures: After review of Statement of Cash Position, Expense Report, Expense Transaction Ledger, U.S. Bank Transaction Search, and various GMIS Monthly expenditure reports, a motion was made by Lois Herrell to pay the bills and seconded by Brenda Shipley. Motion passed.

Approval of minutes: A motion was made by Lois Herrell to approve the minutes for the July 18th, 2021, Lawrence County Board of Health meeting. The motion was seconded by Brenda Shipley. All were in favor, the motion passed.

Approval of reports received: A motion was made by Lois Herrell to approve the reports received. The motion was seconded by Brenda Shipley. All were in favor. Motion Passed.

The approved reports included:

Sanitation, vital statistics, burial permit fee, accreditation, car seat / cribs, reproductive health, maternal and child health program, COVID-19 care resource coordination support, Coronavirus response supplemental, COVID-19 enhanced operations, public workforce, Pallottine foundation, public health emergency preparedness, COVID-19 vaccine equity supplement, COVID-19 vaccine needs assessment, get vaccinated Ohio, and immunizations.

Angela provided updates regarding two new grants. The public workforce grant starts 9/1/2021 and ends 6/3/2023, for a total of \$230,000 to be used in relation to Covid. The second grant was from the Pallottine foundation in connection with the St.Mary's Sisters from West Virginia, for a total of \$15,000. 100% of the Pallottine grant is intended to go toward salaries.

Brenda Shipley made a motion to accept Resolution 08182021a and Resolution 08182021b. The motion was seconded by Lois Herrell. All were in favor. The motion passed. Resolution 0818201a authorizes Zach Schweinsberg, Fiscal Officer, to initiate line-item transfers within any fund. Resolution 08182021b authorizes the payment of late fees / interest charges to Sam's Club in the amount of \$341.80. It is anticipated that the actual late fees / interest will be lower when the next statement arrives.

Georgia Dillon provided an update on sanitation/environmental reports. Food inspections have been performed. Late fees were temporarily waived, this ended 7/1/2021. There were 18 animal bites in July, 20 nuisance complaints, 8 septic systems, issued 6 septic permits. 8 properties were sold. Paul has been working hard on WPCLF related activities.

Adjournment: Brenda Shipley made a motion to adjourn the meeting at 5:05 PM. The motion was seconded by Lois Herrell. All were in favor. Motion passed.
