# Lawrence County Health Department Board of Health February 19, 2020 MINUTES

## 1. Roll Call

The roll call was taken by Randall Lambert at 11:30 am. Those present were Randall Lambert, Curtis Anderson, Mark Dickess, Lois Herrell, Brenda Shipley. Also present were Georgia Dillon and Phyllis Becker.

## 2. Approve Minutes

Randall Lambert call for motion to approve the minutes. Lois Herrell made a motion to accept the minutes as read; Curtis Anderson seconded the motion. A vote was taken and motion was passed. Minutes approved.

## a. Expenses

## 1) Approval of Expenditure

## 1) Acceptance of resignation

Georgia Dillon brought to the Board Gina Bogg's resignation letter which was dated 2/24/2020. Mark Dickess made a motion to accept the resignation, Curtis Anderson seconded it; a vote was taken and motion was passed.

### c. Resolution 02192020b

1. Resolution to appoint Registrar, Deputy Registrar and Clerk

Georgia Dillion brought before the Board the necessity to move Mary Davis into the position of Registrar, Debbie Fisher into the position of Deputy Registrar, and Fran Klaiber into the position of Vitals Clerk. Curtis Anderson made a motion to appoint the mentioned persons to the positions needed as stated above. Brenda Shipley seconded the motion. Randall Lambert called for a vote. A vote was taken and the motion passed.

#### 1) Change in pay rates

Ms. Dillon further stated that because of these added responsibilities, it would be necessary to increase each person's pay rate \$2. A motion was made by Curtis Anderson, that because of the change of job description and the new position, that each person should be given the pay increase of \$2. Brenda Shipley seconded the motion. A vote was called and the motion was passed. All three persons are to receive a \$2 raise.

## d. Resolution 02192020a

## Re-visit Section 5.02 Sick Leave Conversion for employees that started prior to January 1, 2008

The next order of business to come before the Board was to re-visit discussion of creating a new fund for Employees Severance Costs. (Resolution No: 02192020a). As per previous discussion, Section 5.02 Sick Leave Conversion for employees that started prior to January 1, 2008, the Board wanted clarification from the auditors that they could create a Severance fund to cover the costs that the Board will have. Phyllis Becker shared that she had discussed this matter with Chris Kline and he said that it would be a good plan, and that all that would be needed would be a resolution

and the minutes from the Board meeting. With approval received from the auditors, Mark Dickess made a motion to approve resolution 02192020a to create a Severance Costs Fund with a beginning balance of \$30,000 to be taken from the Board of Health Fund and the Public Health Nursing Fund equally. Curtis Anderson seconded the motion. Randall Lambert called for a vote. The vote was taken and the motion was passed.

## d) Resolution 02192020c

1) Resolution to Apply, Accept and Enter into a Water Pollution Control Loan Fund Agreement Georgia Dillon explained the WPCLF agreement to the Board. She stated that this was water pollution control loan fund agreement on behalf of the Health District of Lawrence County for the repair and/or replacement of home sewage treatment systems. In order to receive these funds, the Board must make a resolution to authorize Georgia Dillon to apply for a WPCLF assistance agreement, sign all documents for and enter into a WPCLF with the Ohio Environmental Protection Agency for the repair and/or replacement of failing HSTS on behalf of the Health District of Lawrence County, Ohio. Curtis Anderson made a motion to accept Resolution 02192020c that would give Georgia Dillion authority to apply for and sign all necessary paperwork to obtain WPCLF Funds. Mark Dickess seconded the motion. Randall Lambert called for a vote. A vote was taken and the motion was passed.
